New Business

- 1. 2020 Schedule. Vote to approve.
- 2. 2020 Budget vote is delayed to Jan 2020 due to treasurer on vacation.
- 3. NYE 2020. Who is Chairing? Budget? Ticket pricing? Tickets to go live in Jan. I propose a budget of \$5000 for band, \$1500 for sound, \$1200 for snacks, \$800 rent, \$300 staff. That totals at \$8800.00. Proposed ticket price of \$30. Market to only swing dancers. Event is funded at 294 tickets sold, leaving room for profit. Keep this event casual and fun and DANCER oriented.
