

Attendance 2015-2018








Attendance and Revenue Trends




Attendance and Revenue Sources (2018 1H)

- Anniversary Dance (6/28)
 - Attendance = 359
 - Expenses $\approx $4,400$
 - Revenue = \$2,748
 - Total loss \approx \$1,650
 - Total loss (if members paid) \approx \$850
- Spring Swing (4/12)
 - Attendance = 284
 - Expenses \approx \$2,107
 - Revenue = \$2,667
 - Total profit $\approx 560

- Last Thursday (7/12)
